The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 Hrs on 2077/06/13 (29th Sept 2020) at the office of Lisankhu Pakhar Rural Municipality, Attarpur, Sindhupalchok. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, which shall be valid for 30 days beyond the validity period of the bid (i.e. 2077/09/14 (29th Dec 2020))
