- The Government of Nepal (GoN) has allocated TB-SWAp funds to Lisankhu Pakhar Rural Municipality for Trail Bridge 1. Program and the Rural Municipality intends to apply the funds to cover eligible payments under the Contract for supply of fabricated steel parts for Trail Bridges. Bid is open to all eligible Nepalese Bidders.
- The Lisankhu Pakhar Rural Municipality invites bids from registered fabricators for supply of fabricated steel parts for 2. following Trail Bridges. Detailed Evaluation and Qualification Criteria are provided in Section III of the Bid Documents.
- The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum five 3. trail bridges within last five years. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted in nepaltrailbridges.org.np may also apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the requirements.

- A complete set of Bidding Documents may be purchased from the office, Lisankhu Pakhar Rural Municipality, Attarpur, 5. Sindhupalchok by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee as mentioned in the table below till 2077/09/24 during office hours.
