- 1. The Government of Nepal (GoN) has allocated TB-SWAp funds to Lisankhu Pakhar Rural Municipality for Trail Bridge Program and the Rural Municipality intends to apply the funds to over eligible payments under the Contract for supply of fabricated steel parts for Trail Bridges. Bid is open to all eligible Nepalese Bidders.
- The Lisankhu Pakhar Rural Municipality invites bids from registered fabricators for supply of fabricated steel
  parts for following Trail Bridges. Detailed Evaluation and Qualification Criteria are provided in Section III of the
  Bid Documents.
- 3. The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum five trail bridges within last five years. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted in nepaltrailbridges.org.np may also apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the requirements.
- 4. Eligible Bidders may obtain further information and inspect the bidding documents at the office of Lisankhu Pakhar Rural Municipality or www.bolpatra.gov.np
- 5. A complete set of Bidding Documents may be purchased from the office, *Lisankhu Pakhar Rural Municipality, Attarpur, Sindhupalchok* by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee as mentioned in theb table below till 2077/11/04 during office hours. Or,

Bids will be opened in the presence of Bidders' representatives who choose to attend at Lisankhu Pakhar Rural Municipality at 13:00 hrs on 2077/11/05 at the office of Lisankhu Pakhar Rural Municipality, Bids must be valid for a period of 45 days after bid opening and must be accompanied by bid security, amounting as mentioned in the following table, which shall be valid for 30 days beyond the bid validity period.
- 8. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day.
