The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hours on 2079/04/22 (7th August 2022) at the office of Lisankhu Pakhar Rural Municipality, Attarpur, Sindhupalchok. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format ammounting to minimum of NRS 1,61,000.00, which shall be valid for 30 days beyond the validity period of the bid (i.e. 2079/07/22).
